#### **DIVISION MANAGER STAFF REPORTS**

Tally Peek for Support Services/GIS – Support Services continues to take Homestead applications and have begun precoding transfers for TY2024. GIS has begun reviewing Platts for 2024. Clerical staff has been assisting taxpayers on the phone and in person and entering appeals as they are received.

Gabrielle Rowse – Appeals Coordinator – As of today 418 appeals have been received manually and 336 have been received online. Of those received 611 are Residential, 98 are Commercial and 45 are Personal Property.

Julie Marine for Residential – Staff has begun reviewing appeals and assisting taxpayers with questions as well as starting Field Reviews for TY2024.

Kevin Hicks for Quality Control – ABOS has the patch in place to run in test mode. Mobile Appraiser is all ready for test mode and in house training will begin on June 20<sup>th</sup>. We met with the vendor of Just Appraised last week to discuss our office processes and the development of the software. The TY2023 Digest has been completed and sent to the local municipalities.

Lisa Lowrimore for Personal Property/Commercial – Commercial has received 98 appeals to date and staff has begun reviewing them, Field Reviews have started, and staff is working on Appeal Waivers. Personal Property has received 45 appeals to date, Freeport applications are being reviewed and preparing recommendations.

#### 1. Chief Appraiser Items

- A. CAVEAT Update The breakout sessions contained a lot of great and useful information. There were many new legislations discussed. The ones that mostly affect the office are SB215 which allows police officers and peace officers to request their information to be unlisted, HB311 which covers federally declared national disaster site options for a county to adopt tax credits for any structures that were impacted. Also, discussed was the Homeowner's Tax Relief and some misconceptions were cleared regarding the parameters. HB121 covers the requirement of off-road vehicles (i.e., four wheelers, golf carts, side by sides, etc.) to have a motor vehicle tag. Although they will have a motor vehicle tag they will be considered as personal property and will remain on the personal property rolls. The event was well attended.
- B. Digest Comparisons The TY2022 Digest had an error for Pooler. The error was corrected. However, the Department of Revenue has informed us that year to year comparisons must use the previously advertised values regardless of digest corrections. With the overall County increase was 10.37%, School was increased 13.73% 11.13%, others in the county essentially remained the same except for Pooler where the error occurred increasing 31.18% 13.74%.
