

Gabrielle Rowse for Appeals – We have received 82 more appeals than this time last year. 556 Appeals are hard copies and 679 were filed online. As of today, we have received 1,235 appeals of those 925 are Residential, 253 are Commercial and 57 are Personal Property.

Tally Peek for Support Services – Support Services continues transferring deeds for TY2025 in Just Appraised and taking Homestead Applications as taxpayers come in. GIS is reviewing Platts for Splits/Combos. Clerical staff is entering appeals as they are received and helping taxpayers over the phone and in person.
