DIVISION MANAGER STAFF REPORTS

Tobe Northcutt for Residential – Working on Appeals and preparing presentations and preforming site inspections as needed, addressing appellant concerns as they arise as well as assisting taxpayers over the phone and in person. We have begun using Mobile Appraiser and feel that productivity and efficiency will increase as we learn the software.

Gabrielle Rowse for Appeals – To date 3,168 manual appeals and 1,610 online appeals were received for a total of 4,778 appeals. Of those received 3,575 were Residential, 912 were Commercial and 291 were Personal Property. There were 219 Hearing Officer appeals and 14 Arbitration appeals.

Marsha Lucree for Commercial/Industrial – Working on Appeals and preparing presentations. Training and getting comfortable using Mobile Appraiser.

Jill Studer for Personal Property – Working on and reviewing Appeals, reviewing Freeport exemptions and 50% complete with the approval/denial letters and auditing business accounts continues.

Tally Peek for Support Services/GIS – Support Services has processed 366 Homestead Applications, 300 Transfers and continues Precoding. GIS is reviewing Platts and working 24 Split/Combo packets. Clerical staff continues to enter Appeals as they are received.

Kevin Hicks for Quality Control – Addressing ongoing Tyler Tickets, there was great training with the people from Mobile Appraiser the week of June 20 and staff showed a lot of enthusiasm for the product. Just Appraised is still in the technical phase getting things set up. We continue to stay in contact with the state regarding the Digest Submission.
